
ETFGI is hosting the ETFGI Global ETFs Insights Canada Summit on November 27th in Toronto.


- ETF MANIA: <u>Global ETFs beat prior full year flow record with 2 months to spare</u> after attracting US\$211.4B inflows in October, YTD inflows surged to US\$1.45Tr easily breaking 2021's full-year record of US\$1.29Tr. Assets of the Global ETF industry <u>have ballooned to US\$11.63Tr (+23.9% YTD)</u>.
 - As of Nov 15, the <u>US ETF industry also broke the 2021 record attracting US\$913B inflows this year</u>, after the monster haul following the US election.
 - Assets in European ETFs have climbed 21.9% YTD to US\$2.22Tr at the end of October. Similarly to other regions, <u>ETFs in Europe are also enjoying record inflows (US\$207.79B)</u>.
 - **Canada not left behind:** <u>Canadian ETFs have also attracted record inflows</u> YTD (+C\$73.5B), breaking 2021's high. Assets of Canadian ETFs now stand at C\$554B (+41% YoY), with 5 new issuers coming to market in 2024.
