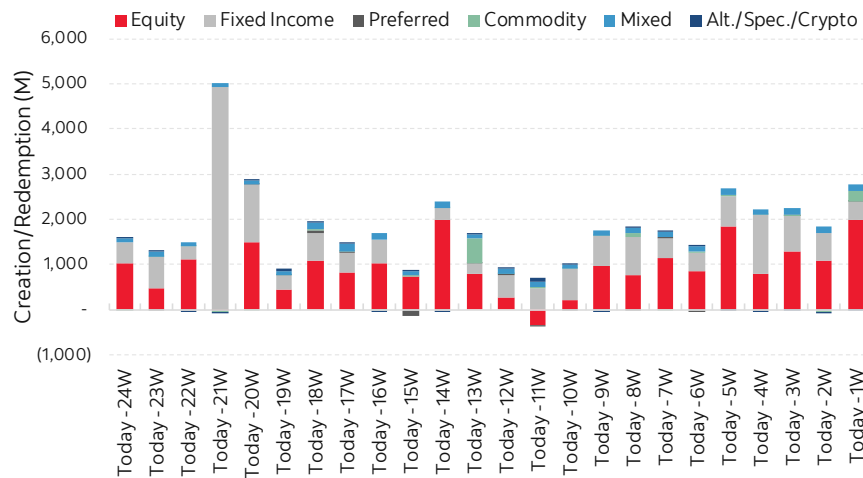

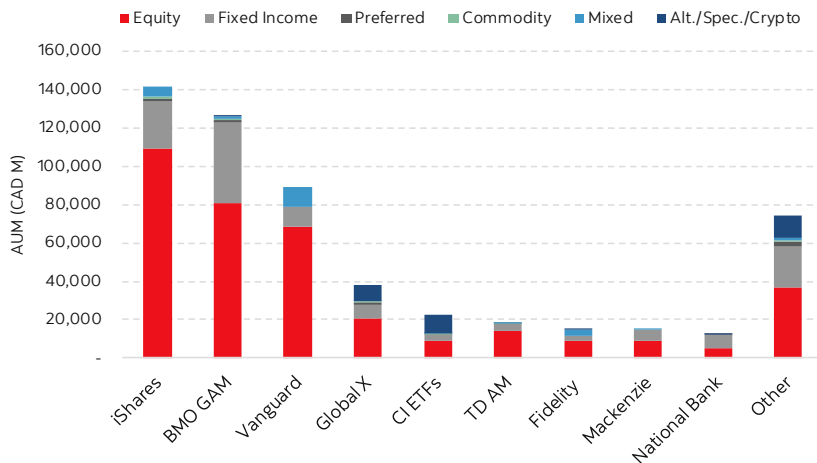

The five largest providers now account for 75.4% of the ETF Canadian landscape



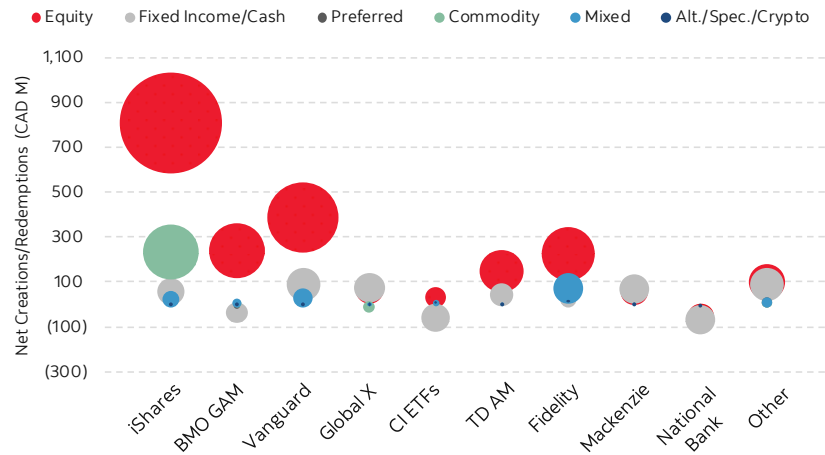
