

Notable Weekly Market News


- New ETF AUM Records (Again!): Globally listed ETFs reached US\$13.99T in assets at the end of August as cash continues pouring into ETFs (+US\$130.1B in August). YTD ETF flows hit a record US\$1.07T ETFGI expects ETFs to finish with over US\$1.3T inflows in 2024.
 - o The <u>US ETF industry grew to a record US\$9.74T in AUM</u> after US\$66.3B inflows in August the US ETF market is close to reaching US\$10T in AUM, with YTD inflows of US\$643.5B.
 - o In Canada, ETF assets have jumped by 20.7% from the start of the year to a record US\$378B at the end of August. ETFs in Canada have also seen record flows YTD: +US\$36.62B.
 - o <u>Europe not left behind</u>: ETFs have seen over US\$150B inflows YTD, pushing ETF assets to US\$2.18T, yet another record.
- <u>Half-penny ticks</u>: Last week, the US SEC approved rules that will allow thousands of stocks and ETFs traded on exchanges to be quoted in half-penny increments. Analysts believe this change could boost exchange volumes.
- Last week, the CSA published for comment a <u>series of proposed amendments</u> aimed at modernizing the continuous disclosure regime for investment funds. These <u>proposals are designed</u> to provide investors with more focused and valuable disclosure while reducing the regulatory burden on investment fund managers.
